Dear Neighbors:

Let me begin by thanking all of you who have supported The Community Fund of Bronxville, Eastchester, and Tuckahoe over the years. Without your donations we would not be able to accomplish our mission to "help members of our community with their most pressing needs." So thank you!!

To fulfill this mission, we spent the last year plus working with Pace University to conduct a community-wide needs assessment. This project entailed surveying the community at large, conducting interviews with residents, governmental officials, nonprofits, and local business owners to determine the most pressing needs of the community. (The results of our needs assessment can be found on our website). We discovered that the largest gap between needs and services existed in issues surrounding mental health and well-being. This was true for all three communities.

We have already initiated a process of looking at how we can help to fill this gap. We are looking at ways to allocate grant money to new mental health programs that will serve our community. We are re-examining our grants process and our evaluation process to assure that these needs get served. We are speaking with nonprofits, with whom we might not have worked with before, that focus on mental health and seeing how we can help them to provide services to our community. We have also engaged with governmental officials and local organizations to help assess ways this important issue can be addressed.

While looking at new ways to address mental health issues in our community, we are continuing to support those agencies that currently service our community — from providing social outlets to our seniors, addressing food insecurity, teen programs, and many more. These vital services also indirectly address mental health in trying to address social isolation, drug addiction, and additional stress before it becomes an issue. The Community Fund is evolving as the needs of our community evolve, but still committed to those programs that our residents hold so dear.

As you can see, exciting things are ahead from The Community Fund of BET. 5 REASONS WHY Getting Involved with The Fund is good for your health!

There is a Direct Need in Your Community

There is great need all over the world. However, many people overlook the significant issues in their very own town, city, and even country. Giving to The Fund can help you discover the need within, identifying where change is required to make your community more sustainable.



2 The Fund Does the Leg Work for You

One of the biggest benefits in working with The Fund is that you are alleviated from the burden of finding a trusted way to get your donation to those who need it most. With that "leg work" out of the way, you'll find peace of mind that your contribution is going to a worthy organization.

3 Provides a Sense of Community

When you donate to The Fund, you don't just drop a check in the mailbox and be done with it, unless that's what you want. Many people become involved to a deeper degree with The Fund, following updates via a newsletter, on social networks, or through some other point of contact and donor involvement programs. For example, in addition to financial contributions, The Fund provides opportunities for you to have a better understanding of local nonprofits through evaluating opportunities.

You can be involved as much as you like, but there's only one addendum – be prepared to gain a few new friends in the process!

4 Goodwill is Good for Your Health

Did you know that supporting a charity is actually good for you? In fact, studies show that those who give tend to live longer. Another University study found that altruism resulted in an increase in health benefits in people with chronic illnesses. Those who donate and get involved with important causes also report improved self-esteem and self-worth, an elevation in mood, and an enhanced ability to form social connections, all of which have proven physical health benefits, too.

Even better, giving is contagious. A shared study between the University of California and Harvard University found that when one person behaves generously, it inspires observers to behave the same at a later point in time, through their own channels. This selfless behavior reportedly has a three-degree effect, jumping from one person to the next, and the next. Now that's one contagion we can actually get excited about!

5 Tax Benefits

Last but not least: a financial benefit comes to you. Tax deductions are fiscally beneficial and can be applied to your taxes at fiscal year-end. And guess what? Studies show that tax subsidies for charitable giving reduce stress and strengthen the immune system, further extending upon the reported health benefits of doing good for others.





NEEDS ASSESSMENT for the Community in partnership with PACE University

Researchers Identify Gaps in Services

In 2021, The Community Fund selected experts at the Helene T. and Grant M. Wilson Center for Social Entrepreneurship at Pace University to conduct a survey of community members and analyze results.

During this 18-month partnership between The Community Fund and Pace University, Pace Public Administration and Wilson Center faculty and researchers developed an in-depth community survey and held interviews with select community members and leaders in the areas of public health, human services, business, nonprofits, and government. All responses were treated as confidential to ensure the greatest possible degree of candor.

Wilson Center and Public Administration faculty and graduate students have completed a variety of in-depth research projects and reports for local governments and community organizations across a variety of areas, including an assessment of K-12 learning programs for the Westchester Children's Association; the economic impact of the nonprofit sector in Westchester County; a community assessment of performance for the Port Chester Police Department; and Pace University's overall economic impact in New York State.

 Mental health, counseling, substance abuse, and suicide prevention services are among growing needs in lower Westchester that were identified by a team of Pace University faculty researchers during a survey of community organizations.

The assessment identifies gaps or inadequacies in areas such as human services, health care, housing, public safety, day care, and recreation, among other vital community needs. Findings were presented on March 29, 2023 at The Bronxville Public Library by Pace University faculty who identified ways to use the results to inform the important work of The Community Fund as well as nonprofit agencies, community programs, and local school administrations.




Community Grant Investments

TOTAL COMMUNITY INVESTMENT FY 2023 \$513,842 FY 2024 \$589,104






Community Investments by Demographic Sector FY 2023 and FY 2024



Our Grant Process



The Community Fund evaluates grant proposals and designates donor dollars through 3 different grant processes.

This year we were able to harness the power of over 200 volunteers to disperse \$500,000.

1. Member Agency Fund Grants

Agencies which receive funding for their operating and administrative budget as well as for program support are considered "Community Fund Member Agencies." Member Agencies are nonprofit organizations and community programs that service the Bronxville, Eastchester, and Tuckahoe communities and fall into 5 Sectors of Impact: Youth, Seniors, Education and Prevention, Family, and Health. Individual grants range from \$2,000 to \$60,000 yearly.

2. Discretionary Fund Grants

Discretionary grants are meant to fund either a specific time-limited project/program or provide seed money for a new initiative. Programs in this category are generally funded for one year and a maximum of \$10,000 is dispersed. These one-time grants give The Fund the flexibility to help support an immediate need for an agency or community program, or seed a new initiative that can dramatically impact the lives of our residents. In the last 10 years The Fund has given over \$225,000 through these discretionary grants.

3. Youth Community Fund Grants

Youth Community Fund grants aimed at supporting local youth initiatives that YCF deems appropriate. Grants are supported through YCF fundraising efforts.

YOUTH COMMUNITY FUND 2022–23 Highlights

The **3-on-3 BET Youth Basketball**

Tournament was held on October 16th and featured 25 teams and 80 middle and high school players from Bronxville, Eastchester and Tuckahoe. The event included a community BBQ with the Tuckahoe, Bronxville and Eastchester Police Departments, DJ, the mayors from all three towns, seven community sponsors, and a visit from Tuckahoe's own dunk champion, Maxwell Pearce. More than 20 YCF volunteers kept the day running smoothly. The Tuckahoe Main Street Courts were refurbished in recent years by a grant from The Community Fund and were the perfect place to gather and enjoy a day of fall basketball.

The **Bronxville Ballet Not For Sale Dance Partnership** ran from September to May. The program grew from 1x month last year to 2x month this year and a new holiday social was enjoyed by all who participated. This program was funded with grant money awarded by YCF in 2021-22. YCF volunteers donated their time to several community service events throughout the year, including the **Tuckahoe Village Candy Crawl, Eastchester Winter Festival, Eastchester Teen Scene and Bundles** of Joy youth service projects.

The award-winning **Angst: Raising Awareness Around Anxiety**

documentary screening was held at The Bronxville Picture House on March 6th. This was YCF's first-ever film screening and originated from a grant written by YCF members. The event welcomed more than 130 Bronxville, Eastchester and Tuckahoe teens and their parents and served as a conversation spark about teen anxiety and mental wellness. YCF volunteers staffed and promoted the free community screening. Several high school students took the stage to give background on the program and lead a group activity for the audience.



The YCF Thanksgiving Diaper Drive

collected 3,600 diapers for area non-profit, Bundles of Joy.

YCF **partnered with South East Consortium** for several **themed peer-to-peer socials**,

including Trivia Night, Karaoke Night, the Summer Dance Party, the Blizzard Ball, the Super Bowl Bash, and the Glow Party.

Our second annual **YCF Paddlefest Fundraiser** took place on February 12th and welcomed more than 60 area high school students for an afternoon of friendly paddle matches, firepits, and a DJ. YCF members staffed the event and contributed homemade baked goods. The event featured the talents of local high school students – a student DJ kept the mood festive and a student business founder/baker donated prizes!

Members of YCF's **Evaluations Committee** shadowed The Community Fund's grant evaluation program, learning from the 30 adult community volunteers who lead this community initiative each year. Students were able to read grant applications, attend and participate in evaluation interviews, and attend the agency presentation evening. Look for more exciting grants news coming later this spring.

In January, YCF organized a free **teen yoga class** during high school midterms, continuing the theme of mental wellness for our teens.

Behind the scenes, YCF members have written articles and social media posts, organized meetings and events, and sharpened their public speaking skills.




